

Contest Rules

Monthly Contests for Members

- 1. Poems must be postmarked by the first Saturday of the month.
- 2. Members may enter one poem per month with a limit of 36 lines unless directions are otherwise.
- 3. Entries must be mailed to: Renee Ramsey, 249 Garden Lane, Floral, AR 72534.
- 4. Poem must be original, unpublished.
- 5. Two copies; place name and address on one copy only in the upper right corner.
- 6. Winners receive a check for \$15, \$10, \$5 and are listed on the website.
- 7. Three HMs may or may not be awarded. Contest results are to be announced by the end of the month.
- 8. If a different website is not listed, poetry form should be found at shadowpoetry.com.
- 9. Titles and blank lines are not counted in line limits.

Sybil Nash Abrams Award

- 1. Open only to PRA members who are Arkansas residents; 60 100 lines.
- 2. Poem must be original, historically accurate, unpublished.
- 3. List sources (historical) on separate page.
- 4. First place winner cannot enter for the next four years.
- 5. Executive Board selects subject, to be published on the website and in *News 'N' Notes*.
- 6. Executive Board compiles a list of nominations of judges to present to the Committee Chair.
- 7. Last four winners form the committee chaired by the earliest PRA member winner; Committee members make nominations to the Committee Chair. Committee Chair selects a judge. The 2024 committee:

Student Awards

On June 27, 2024, Gregory Lathrop donated funds to the Poets' Roundtable of Arkansas to fund the PRA Student Contest. In the event that Poets' Roundtable of Arkansas ceases to function, the funds in the account shall be made available to another Arkansas poetry association selected by the Trustees (PRA). Trustees are the PRA President, PRA Treasurer, and any other PRA Board Member the PRA Board deems needed. Lathrop Investment Management Corporation manages the account and Charles Schwab is custodian.

Awards shall be paid to winners by the PRA Treasurer at the Dr. Lily Peter Spring Celebration. Amounts of the awards shall be: Senior Division - 1st Place, \$75; 2nd Place, \$50; 3rd Place, \$40; 1st, 2nd, 3rd Honorable Mentions, \$10 each. Junior Division - 1st Place, \$50; 2nd Place, \$35; 3rd Place, \$25; 1st, 2nd, 3rd Honorable Mentions, \$10 each. Amounts of awards may be increased at the discretion of the trustees. Only Arkansas students shall be eligible to enter this contest.

Rules for the Poets' Roundtable of Arkansas Student Contest, the Manningham, and NFSPS Student Contests will be distributed to schools, PRA branches and newspapers by the Contest Chair. Local branches are encouraged to recognize winners in their areas.

Poets' Roundtable of Arkansas student winners will be invited to the Dr. Lily Peter Spring Celebration to read their poems and to receive their awards. Contest Chair will mail awards to the winners unable to attend the meeting.

Spring Celebration Poetry Contests for Members

Members need not be present to win. The same poem may not be entered in more than one contest. All judges will be non-PRA members.

<u>Dr. Lily Peter Memorial Award</u> (sponsored by Roxie Wilson)

- 1. 1st place prize, \$50; 2nd place, \$30; 3rd place, \$20; and up to three HM.
- 2. Contest open to PRA members only.
- 3. Poem must be original, unpublished, 36 line limit.
- 4. Submit two copies, name of contest top left on both.
- 5. Place name and address of poet on one copy only.
- 6. Mail no earlier than January 1 and no later than February 28 (postmark) to: John McPherson, 111 Jawanda Lane, Searcy, AR 72143

<u>Verna Lee Hinegardner Memorial Award</u> (sponsored by John Crawford)

- 1. 1st place prize, \$50; 2nd place, \$30; 3rd place, \$20; and up to three HM.
- 2. Contest open to PRA members only.
- 3. Poem must be original, unpublished, 36 line limit.
- 4. Submit two copies, name of contest top left on both.
- 5. Place name and address of poet on one copy only.
- 6. Mail no earlier than January 1 and no later than February 28 (postmark) to: John McPherson, 111 Jawanda Lane, Searcy, AR 72143

<u>Freeda Baker Nichols Memorial Award</u> (sponsored by Pat Laster)

- 1. 1st place prize, \$50; 2nd place, \$30; 3rd place, \$20; and up to three HM.
- 2. Contest open to PRA members only.
- 3. Poem must be original, unpublished, 36 line limit.
- 4. Submit two copies, name of contest top left on both.
- 5. Place name and address of poet on one copy only.
- Mail no earlier than January 1 and no later than February 28 (postmark) to: Pat Laster, 7433 Samples Rd, Benton, AR 72019

Spring Celebration Serious or Light Verse Contest

- 1. One original, unpublished poem may be entered in either the Serious or Light Verse contests.
- 2. The light verse will have a 16 line limit.
- 3. The serious verse will have a 16 line limit.
- 4. Submit one copy without a name.
- 5. Place category in upper right corner.
- 6. Judging will be by secret ballot (popular vote).
- 7. \$10 award, each category, (\$10 each, for tie).
- 8. Poems must be turned in by the end of the first break.
- 9. Poet **must be present** to win.

News 'N' Notes

The 2024-2025 *News 'N' Notes* will be published on the website quarterly. Because *Strophes* appears on the NFSPS website, printed copies will be mailed to members by request only. The editor is paid a stipend of \$50 for each published issue, plus expenses. The Yearbook editor is paid a stipend of \$50, plus expenses.

Anthology Information

The President shall appoint the editor who will select at least two PRA members to serve on the committee.

- A. The editor is authorized to publish the following:
 - 1. Poems submitted by PRA members that have
 - a. won \$5 or more in a contest,
 - b. won an HM in an NFSPS contest,
 - c. been approved by the editorial committee.
 - 2. The Sybil Nash Abrams contest winning poems for PRA members and PRA student contests (contingent upon having written consent for publication by the poet).
 - 3. The Collegiate Contest winning poems (contingent upon having written consent for publication by the poet).
 - 4. A poem in memory of each PRA member who has died since the last edition.
- B. The editorial committee may reject any poem.
- C. The editor must place one copy of the anthology in the:
 - Arkansas Studies Institute of the Central Arkansas Library System
 - 2. Arkansas State Library
 - 3. University of Arkansas Library
 - 4. Arkansas State Archives
 - 5. PRA President's set of archived anthologies
 - 6. PRA Historian's set of archived anthologies
- D. The editor will receive a \$100 stipend, plus expenses submitted to the treasurer with receipts, to be paid at the completion of the publication of the anthology.

Poets' Roundtable of Arkansas Constitution

(Last amended April 13, 2019)

Poets' Roundtable of Arkansas was organized in Little Rock, Arkansas, February 5, 1931. The Constitution was adopted October 9, 1976 (in Little Rock). Poets' Roundtable of Arkansas was incorporated in the State of Arkansas April 28, 1977. Nonprofit status was attained April 17, 1978, and sales tax exemption July 1, 1979. (Federal identification number: 71-0503194).

Article I Name, Description, Purpose

<u>Section 1.</u> This organization shall be called Poets' Roundtable of Arkansas.

<u>Section 2.</u> Poets' Roundtable of Arkansas is a nonprofit organization dedicated to the study of poetry and to the encouragement of poets.

Section 3. The purpose of this organization shall be to foster and encourage poets in the art; to promote an appreciation of poetry in the community; and to secure a fuller recognition of the works of contemporary poets in the state of Arkansas.

Article II Membership and Dues

<u>Section 1.</u> The membership of this organization is open to all persons with a sincere interest in poetry, whose dues are current.

<u>Section 2.</u> If a member of Poets' Roundtable of Arkansas is accused of harassing any officer or committee member, or

of striving to disrupt and undermine the goals of this organization, or is accused of deliberate plagiarism, a committee of the Executive Board will investigate the charges. The membership may be withdrawn upon recommendation of at least two thirds of Executive Board and the approval of members by a vote at a regular business meeting.

<u>Section 3.</u> The fiscal year of this organization shall be from July 1 through June 30.

<u>Section 4.</u> Dues shall be reviewed and set by the Executive Board from time to time.

Article III Officers and Committees

Section 1. Officers of this organization shall be: President, Vice President, Secretary, Treasurer, Historian, Parliamentarian, Counselor, and four elected Executive Board Members at Large, designated by the Nominating Committee. All officers will be elected in February by written ballot for a period of two years. Succession to any office is not automatic.

<u>Section 2.</u> The President of this organization shall serve no more than two terms consecutively.

Section 3. The Executive Board shall consist of Officers and Board Members at Large designated in Section 1. Presence of any five elected Board Members shall constitute a quorum at Executive Board meetings. In addition to the elected Board Members, each Branch may designate a member as its Branch Representative to the Board meetings. The Board shall administer the affairs of the organization and shall meet on the call of the President.

Members of the Executive Board shall be notified at least ten days before the time of the called meetings. Executive Board duties shall include selecting the Nominating Committee Chairman, the subject and form for the Sybil Nash Abrams Award, and the recipient of the Merit Award.

<u>Section 4.</u> Committees may be appointed by the President as deemed necessary and approved by the Board.

Article IV Duties for Officers

<u>Section 1.</u> The officers of this organization shall perform individual duties as listed:

- A. President: Shall preside over all meetings of the organization and of the Executive Board; shall call meetings of the Executive Board; shall appoint chairpersons for all standing committees; shall be an ex-officio member of all committees except the Nominating Committee; shall serve as official representative of the organization; shall provide executive leadership in the promotion of organization functions and, in the absence of the Treasurer, will have authority to sign checks for the organization. Delegated responsibilities may include securing grants, copyrights, proclamations, and special certificates. Other responsibilities may include preparation of tax and grant reports, the annual Secretary of State's report, official correspondence, and other duties as requested.
- **B.** <u>Vice President:</u> Shall serve in the capacity of Administrative Assistant to President.
- C. <u>Secretary:</u> Shall record the minutes of the statewide meetings and of the Executive Board meetings; shall

furnish the President with a copy of the minutes of the previous meeting, in advance of the next meeting; shall read the minutes at the organization's meetings at the request of the President or members; shall maintain copies of minutes for transmittal to successor in Office; and shall assist President with correspondence.

- **D.** <u>Treasurer:</u> Shall receive and account for all monies accruing to the organization, according to auditing requirements; shall present a financial report at all regular meetings; shall be responsible for the disbursement of organization's funds; shall prepare an annual financial report; shall have authority to sign checks for the organization; shall provide for an annual audit of the Treasurer's book of the organization's accounts; shall furnish membership lists and dues to NFSPS as required by NFSPS.
- **E.** <u>Historian:</u> Shall arrange for displaying the Scrapbook at state and national NFSPS meetings; and shall be responsible for proper retiring of old scrapbooks at the Little Rock library archives after National Poetry Day in Arkansas.
- **F.** <u>Parliamentarian:</u> Shall interpret rules of order at all regular and Executive Board meetings according to the Constitution and Robert's Rules of Order.
- **G.** <u>Counselor:</u> Shall serve as the advisor to the President.

Section 2. In the absence of the President, the Vice President shall preside. In the event of the President's death, resignation, or inability to serve, the Vice President shall serve as President during the remainder of the fiscal year; or in the event of the temporary inability of the President to serve, so long as such inability continues

during the remainder of the fiscal year. In the event the Vice President is unable to serve as President, the Executive Board shall fill the vacancy for the period of the inability of the President.

<u>Section 3.</u> In the event of vacancies in offices other than the President or of such an officer's inability to serve, the office shall be filled by the Executive Board for the remainder of the fiscal year.

Article V Meetings

Section 1. Poets' Roundtable of Arkansas shall hold two annual statewide meetings. These meetings are to be held on Poetry Day in October and the Spring Celebration. Items included in the agenda shall be submitted to the President as follows: Branches may submit a maximum of two items and at-large members may submit one. All submitted items must be included in the business meeting unless, in opinion of the President, time will not permit the inclusion of all agenda items. In such event, the President shall consult with at least two board members to determine priority of agenda items.

Section 2. Poetry Day is celebrated on October 15, and it will be celebrated by PRA on one of the Saturdays in October. At each annual Poetry Day Meeting, responsibility for the next year's Poetry Day Meeting will be decided.

<u>Section 3.</u> The Spring Celebration will be held in the spring provided that an invitation to host it has been received from a branch or group of poets by the time of the Poetry Day events the previous October.

<u>Section 4.</u> Fifteen members shall constitute a quorum at statewide meetings.

<u>Section 5.</u> All voting at state meetings shall be done in person.

Section 6. Absentee and Proxy Votes:

- **A.** All members of Poets' Roundtable of Arkansas may vote for state officers. A list of candidates will be included in the February *News 'N' Notes*. Space will be provided for write-in nominations. Ballots must be received by the Chairperson of the Nominating Committee no later than February 28 of the election year. New officers will be announced and installed at the Spring Celebration.
- **B.** If, in the opinion of the President, a quorum (5) will not be present for an Executive Board meeting in which essential business is to be conducted, the President may accept up to two proxies from the Board Members so that a vote may be taken. The total number of Board Members present, plus the number of proxies, must satisfy the quorum requirements. Essential business is defined as the election of honorary members, election of a Merit Award recipient, or any other business in which time is of the essence.

Article VI Amendments

<u>Section 1.</u> This Constitution may be amended by the publication of amendments in *News 'N' Notes* and approved by a majority vote of those present at the state meeting immediately following the publication of the proposed changes. Or if mail-in ballots are included with the *News 'N' Notes* edition containing the proposed amendment, a

majority vote of the mail-in ballots received within one month of the publication date of the *News 'N' Notes* will determine the affirmation or rejection of the proposed changes.

Article VII Branches

<u>Section 1.</u> Affiliated branches of this organization are granted autonomous rule in their respective units, provided that the general tenets of this Constitution, particularly Articles I, II, and VI, are deemed governing.

<u>Section 2.</u> A branch must have no fewer than five of its members paying state dues. All officers listed in the *Yearbook* must be members of Poets' Roundtable of Arkansas.

Standing Rules

This revised copy of the standing rules incorporates all changes that were voted by the Executive Board through fiscal year 2023-2024.

Honorary Members: Five honorary members will be maintained by the Executive Board and be selected by secret ballot. The current Arkansas Poet Laureate will be an honorary member for his/her term.

Nominating Committee: The Nominating Committee Chairman will be selected by the Executive Board at the meeting preceding Poetry Day on an election year. The Chairman will select five members and this must include one or more members not on the Executive Board. The official ballot must be submitted to the *News 'N' Notes* editor by January 10 of the election year and included in the February *News 'N' Notes*. Ballots must be received by the Nominating Committee Chair by Feb. 28 of the election year.

<u>Yearbook:</u> No member will be listed more than once in the yearbook membership roster. Pen name or actual names will be noted in parentheses. The latest revision of the Constitution and Standing Rules will be printed in the yearbook.

<u>News 'N' Notes</u>: The deadline is noted on page 10 for publication in August, November, February, and May. Late material will be printed in subsequent issues. Members' achievements will be listed as space permits. Editor is responsible only for processing and editing news items. Members will be advised by *News 'N' Notes* of motions and resolutions. Dues notification is included in the February and May issues. Except for correction of errors deemed

critical by the Poetry Day Chairman, Poetry Day Contest Chairman and President, no revisions may be made to the Poetry Day Brochure after mailing. Postage fees will be prepaid. Secretary sends minutes to editor after they are revised.

<u>Membership:</u> Paid dues will be in effect until the following June 30. First-time members joining within the fiscal year between January and June may pay half price.

Presidential Duties Not Listed Elsewhere: The President shall maintain the morgue, keep current fact sheet for new/prospective members, and will arrange for PRA logo to appear on all official publications and order stationery with logo and letterhead, as approved by the Executive Board, for official use. The President will schedule two Executive Board meetings. The President shall divide the morgue into two files, keep the most complete file and designate a member of the Executive Board to keep the smaller file.

Poetry Day: A donation of \$30 or more is required to sponsor a contest. Smaller donations will be used as needed or designated. The two categories to be listed on the Poetry Day solicitation page of the February newsletter are: (1) PRA Members Only, and (2) All Poets. Entry fee will be a total of \$10 for PRA members, including the Sybil Nash Abrams Memorial Award Contest. Entry fee for non-members is \$15. The only awards that may be presented in Poetry Day festivities are those listed in the Poetry Day Brochure, the Arkansas Merit Award, and those that have received Executive Board consent prior to Poetry Day. The Poetry Day Contest Chair may not enter any Poetry Day contest. Branch members may not enter the contest that their branch sponsors if their branch judges the contest. Expenses for poetry day will be reimbursed. A stipend of \$250 will be given to the featured speaker.

Sybil Nash Abrams Award: On January 21, 2023, the PRA Trustees of the Sybil Nash Abrams Trust donated the Sybil Nash Abrams Trust funds to the Poets' Roundtable of Arkansas Sybil Nash Abrams Account. The Account will continue to be managed and the funds in the Account will continue to be disbursed in the same manner as the Trust. In the event that Poets' Roundtable of Arkansas ceases to function, the funds in the Account shall be made available to any other Arkansas poetry association selected by the Trustees (PRA). (Lathrop Investment Management Corporation manages the Account and Charles Schwab is custodian.) Trustees are the PRA President, PRA Treasurer, and any other PRA Board Member the PRA Board deems needed.

Funds from the Account will be awarded to the 1st, 2nd and 3rd place winners of the poetry contest sponsored by Poets' Roundtable of Arkansas. Only PRA members who are Arkansas residents shall be eligible to enter this contest.

Awards shall be paid to winners by the PRA Treasurer on Poetry Day in Arkansas. Amounts of the awards shall be: 1st Place, \$1,000; 2nd Place, \$400; 3rd Place, \$250. The Sybil Nash Abrams Memorial 1st Place award may be won by an individual only once every five years. The 1st Place winner is not eligible to enter the contest for four years after winning.

The Poets' Roundtable of Arkansas will select poetry form and subject, confining as far as practical to persons, places or things pertaining to Arkansas. The Account will allow up to \$200 fee for a competent judge for the contest as selected by the Chair of the Selection Committee. The committee for the selection of the judge shall be the last four winners of the award. The PRA member who has served longest will be the Chair. The Chair of the Selection

Committee will receive nominations from the President and Selection Committee members. The President will provide the Chair of the Selection Committee with a list of nominees selected by the Executive Board along with the guidelines. The judge must not have any connections with Poets' Roundtable of Arkansas or its members. A non-resident of Arkansas is preferred. Once the judge is selected by the Chair of the Selection Committee, the name of the judge will be shared with the Poetry Day Contest Chair. The name of the judge shall be kept secret by the Poetry Day Contest Chair and the Chair of the Selection Committee until the awards presentation on Poetry Day.

<u>President's Plaque:</u> The Counselor shall be responsible for obtaining the plaque for the outgoing president.

Spring Celebration: Expenses for Spring Celebration will be reimbursed. A stipend of \$250 will be given to the featured speaker.

Membership Coordinator: Shall be appointed by the President in consultation with the Executive Board; shall maintain accurate membership records; shall furnish an updated membership list to the Treasurer, the President and the editors of the Newsletter and Yearbook after July 1st; and shall furnish to the same officers, all additional names, as well as changes in address, phone numbers, or e-mail addresses, received after July 1st.

PRA Website: The website

(poetsroundtableofarkansas.org) exists to attract new members and to inform current members of contests and functions. A \$500 (a year) stipend will be given to the webmaster.

<u>Published Poems:</u> A poem shall be considered published if it has appeared in a publication with an ISBN or ISSN number.

<u>Use of PRA Name and/or Logo:</u> No person or organization may use the Poets' Roundtable of Arkansas name or logo without prior written approval of the official PRA Board.

Arkansas Merit Award: Nominations are presented to the President by the Executive Board or by petition from any branch without a Board Representative. The Executive Board votes by secret ballot. The President counts the votes and breaks any ties. The President is responsible for obtaining the plaque and presenting it at the Poetry Day meeting. The Arkansas Merit Award shall be awarded only once to any individual member, and selections of the award will be based on cumulative contributions promoting poetry.
